INGREDIENTS: Steam crimped corn, re-cleaned whole oats, cottonseed hulls 15%, soybean meal, steam crimped barley, cane molasses, stabilized rice bran, soybean oil, flaxseed oil, calcium carbonate, dicalcium phosphate, monocalcium phosphate, dried marine algae, salt, dehydrated seaweed meal, yucca schidegera, potassium chloride, vitamin A supplement, vitamin D3 supplement, vitamin E supplement, vitamin B12 supplement, riboflavin supplement, niacin supplement, d-calcium pantothenate, thiamine mononitrate, menadione sodium bisulfite complex, folic acid, choline chloride, manganese sulfate, manganese amino acid complex, zinc sulfate, zinc amino acid complex, copper sulfate, copper amino acid complex, cobalt sulfate, cobalt glucoheptonate, ethylenediamine dihydriodide, selenium yeast, sodium selenite, saccharomyces cerevisiae, dried enterococcus faecium fermentation product, dried lactobacillus acidophilus fermentation product, dried bacillus subtilus fermentation product, aspergillus oryzae fermentation product and artificial flavors.

FEEDING DIRECTIONS: Feed **NO. 125 SHOW CALF** continuously at a rate of 6.67 to 24.00 pounds/head/day to provide not less than 100mg. nor more than 360mg. Lasalocid/head/day. Always maintain a supply of fresh hay and water.

CAUTION: The safety of Lasalocid for use in unapproved species has not been established. Do not allow horses or other equine access to feeds containing Lasalocid as ingestion may be fatal.

WARNING: A withdrawal period has not been established for this product in pre-ruminant cattle. Do not use in calves to be processed for veal.
