INGREDIENTS: Steam crimped corn, re-cleaned whole oats, cottonseed hulls 20%, soybean meal, steam crimped barley, cane molasses, distillers dried grain, calcium carbonate, dicalcium phosphate, monocalcium phosphate, calcite, salt, dehydrated seaweed meal, yucca schidegera, magnesium oxide, vitamin A supplement, vitamin D3 supplement, vitamin E supplement, eugenol, cinnamaldehyde, anethole, capsicum, autolyzed brewers dried yeast, extracted citric acid presscake, active dry yeast, brewers dried yeast, saccharomyces cerevisiae fermentation extract, dried aspergillus oryzae fermentation extract, dried bacillus licheniformis fermentation extract, dried bacillus subtilis fermentation extract, vitamin B12 supplement, riboflavin supplement, niacin supplement, d-calcium pantothenate, thiamine mononitrate, menadione sodium bisulfite complex, folic acid, choline chloride, potassium chloride, manganese sulfate, manganese amino acid complex, zinc sulfate, zinc amino acid complex, copper sulfate, copper amino acid complex, cobalt sulfate, cobalt glucoheptonate, ethylenediamine dihydriodide, selenium yeast, sodium selenite, dried enterococcus faecium fermentation product, dried lactobacillus acidophilus fermentation product, dried bacillus subtilis fermentation product, clarifly, (s) methoprene, and artificial flavors.

FEEDING DIRECTIONS: Feed **NO. 135 SHOW CALF** continuously at a rate of 6.67 to 24.00 pounds/head/day to provide not less than 100mg. nor more than 360mg. Lasalocid/head/day. Always maintain a supply of fresh hay and water.

CAUTION: The safety of Lasalocid for use in unapproved species has not been established. Do not allow horses or other equine access to feeds containing Lasalocid as ingestion may be fatal.

WARNING: A withdrawal period has not been established for this product in pre-ruminant cattle. Do not use in calves to be processed for veal.
